EARLY RELEASE - DAN

Jackson Hole High School offers early release for the following programs:

- JHHS Nordic Skiing and Alpine Skiing
- Approved JHHS Partner Organizations (i.e. Jackson Hole Ski and Snowboard Club)

Early Release is subject to the same eligibility criteria as other JHHS activities and athletics.

****Athletes must have practice to early release. If there is no practice, students must remain in school**

JHHS students participating in the early release program with JHSC must meet the following eligibility criteria:

- Maintain enrollment with the Jackson Hole Ski and Snowboard Club, and be in good standing with the JHSC Student-Athlete Code of Conduct and Academic Policy.
- Maintain a completed release of educational records for the JHSC to receive grade, attendance, and eligibility information from JHHS.
- Maintain good behavioral standing at JHHS - disciplinary referrals and suspensions will result in removal from the early release program.
- Maintain academic eligibility at the JHHS regular grade updates - students must maintain a 2.5 GPA and have no failing grades (Ds or Fs). Students who do not meet academic eligibility will be subject to the following progressive consequence:

EARLY RELEASE INELIGIBILITY - DAN

**Once students restore academic eligibility and turn in a completed eligibility sheet, they return to normal early release schedule. Students who do not restore academic eligibility by the end of week 3 risk being removed from the early release program for the remainder of the season.

Early Release Eligibility

JHHS students participating in the early release program with JHSC must meet the following eligibility criteria:

- Maintain enrollment with the Jackson Hole Ski and Snowboard Club, and be in good standing with the JHSC Student-Athlete Code of Conduct and Academic Policy.
- Maintain a completed release of educational records for the JHSC to receive grade, attendance, and eligibility information from JHHS.
- Maintain good behavioral standing at JHHS - disciplinary referrals and suspensions will result in removal from the early release program.
- Maintain academic eligibility at the JHHS regular grade updates - students must maintain a 2.5 GPA and have no failing grades (Ds or Fs). Students who do not meet academic eligibility will be subject to the following progressive consequences:

Upon completion, students will have an elective removed from their schedule and replaced with a study hall. No exceptions will be made to the completion deadline.

JHSC ACADEMIC POLICY - ASHLEY

AUTHORIZATION FOR RELEASE OF STUDENT RECORDS AND SHARING OF STUDENT EDUCATIONAL INFORMATION

My Student _____ ("Student") participates in _____ ("Club") for _____ ("Activity") and is in Grade _____ at _____ ("School"). I understand that, in order for my Student to participate in the Activity offered by the Club, my Student must meet certain eligibility requirements. "Eligibility Requirements" generally shall mean academic, attendance, behavior, and any other requirements identified and used by the Club and School in determining a student's eligibility for participation in the Club Activity. "Student Records" generally shall mean all records kept by the School in the ordinary course of the educational process including, but not limited to, academic, enrollment, attendance, immunization and health, behavior, and disciplinary records or any other information or documentation required by the School. "Eligibility Report" shall mean a list of students who are eligible to participate in a contest, tournament or event for an activity based on meeting certain academic, attendance, behavior or other requirements.

Upon request and generally prior to each event or contest, the School shall be required to provide to the Club Director or designee an Eligibility Report based on review of Student Records by the School setting forth all students participating in the Club Activity who have met, or have not met, the Eligibility Requirements necessary to participate in the Club Activity, event or contest. In the Eligibility Report, the School shall provide an individual student's name, academic grades, attendance record, and whether the student has been suspended, expelled or disciplined in school but shall not provide the Club with copies of the Student Records. The School and Parent shall be required to notify the Club Director or designee immediately if the Student is no longer attending the School, for whatever reason.

In order for the Club to request an Eligibility Report from the School, the Club agrees to obtain written parental consent for disclosure of Student Records and to provide an executed copy of this Authorization for Student Records Release ("Authorization") to the School prior to the beginning of an activity season. Failure of parent to timely provide such Authorization may be grounds for the Club to declare a student ineligible for participation.

Upon receipt, review or inspection of an Eligibility Report provided by the School, and any and all information contained therein, the Club shall be required to maintain the confidentiality of such private and confidential student information and records in the same manner as required by federal and state law in regard to public school student records.

AUTHORIZATION FOR STUDENT RECORDS RELEASE

JHSC requires student-athletes U14 and older to sign a Release of Records per each school's guidelines. Our policy is that we use this information for determining eligibility for JHSC activities and no other purpose.

JHSC ACADEMIC POLICY - ASHLEY

JHSC requires that student-athletes in grades 6-12 maintain a GPA of 2.5 and no “D”s or “F”s.

In order to do so, official eligibility checks at JHHS will be conducted at semester end and on **specific dates set by the Teton County School District each year.**

Student-athletes that fall below the eligibility requirements at any time may be suspended from JHSC participation until grades meet minimum requirements using the following timeline:

Week 1: Parent receives a phone call from JHSC Student-Athlete Support Director. Program Director and coach(es) are notified. *Student-athlete may continue to participate in any JHSC activities if s/he meets with Student-Athlete Support Director for 1 hour to construct an academic plan.* Subsequent to that meeting the Student-Athlete Support Director will closely monitor execution of that plan and academic progress to determine if athlete may continue to participate.

Week 2: Student-athlete will be suspended from all JHSC activities and must meet with Student-Athlete Support Director for 2 hours/week of academic support until grades meet JHSC minimum requirements.

CHRONIC INELIGIBILITY - ASHLEY

CHRONIC INELIGIBILITY: When a student-athlete does not regain eligibility after Week 2.

Reason: The current policy assumes that a student-athlete will regain eligibility within two weeks of dropping grades to Ds, Fs, or below 2.5 GPA. However, if a student does not regain eligibility after two weeks, there is a need for a plan to address the underlying issue. At this point, the student-athlete is at the limit of what the Club can provide, and outside resources will need to be brought in.

If a student-athlete is deemed “chronically ineligible”:

Under no circumstances will they be allowed to return to participation in JHSC activities until a mandatory meeting is held with PDs and coaches to discuss steps that need to be taken before further participation. Goals of this meeting include:

- a. Identify underlying issues and what the student-athlete needs to be successful
- b. Setting a timeline for completion of next steps
- c. Choosing which sources of outside help are needed. Examples include but are not limited to:
 - i. School Counselor → Is a special accommodation plan needed?
 - ii. Curran Seeley → Are there other areas/factors that need support (ie. substance abuse, etc.)?
 - iii. Teton Behavior Therapy → Does student-athlete need study skills help?
 - iv. Public Health Counseling → Are there mental health issues to address?

CHRONIC INELIGIBILITY (CONTINUED) - ASHLEY

Student-athlete will continue to attend two hours of study hall per week with Student-Athlete Support Director or provide evidence of outside tutor support until eligibility is regained.

- a. In this context, “study hall” refers to JHSC’s weekly sessions with Student-Athlete Support Director, and “tutoring” refers to one-on-one sessions with an outside professional.
- b. If student-athlete works with an outside tutor, they will stay in contact with and update SASD each week about progress.

There may be special considerations:

- a. At the end of Semester 1, if the student-athlete is ineligible, they will start Semester 2 ineligible as well until they get their grades are above a 2.5 with no Ds and Fs.
- b. If the student-athlete has special accommodations at school, communication will include school counselor, and specific goals will be defined that are appropriate for that student-athlete in order for them to regain eligibility.
